Mutual Funds	To contribute closed-end mutual funds , provide instructions to the transferring firm: Name of Account: Bradley Impact Fund, Inc. Account number: 2862-5996 DTC Number: 0141 (Wells Fargo Clearing Services, LLC) Notify Bradley Impact Fund at (414) 291-2500 . To contribute open-end mutual funds , please contact Bradley Impact Fund at (414) 291-2500 so that we may provide the necessary custom information to your financial institution.	Processing times can vary, but typically will take two weeks for closed-end mutual funds and up to four weeks for open-end mutual funds. To ensure proper processing, we suggest initiating this request by December 1 for open-end mutual funds and December 15 for closed-end mutual funds . Assets must be received by December 31 to be counted in the 2023 tax year.
