ESTATE COMMITMENT FORM

When directing an estate gift to the Bradley Impact Fund, please complete this form and return it by email to **donorservices@bradleyimpactfund.org** or return it by mail to the address above. This will establish a new donor-advised account or prepare your current account to receive the gift. If you do not submit this form to the Bradley Impact Fund or make other arrangements to specify the use of the gift, the Fund will direct any estate received to the Partnership Fund.

SECTION A: ASSETS

Bequest To name the Bradley Impact Fund as a beneficiary in your will, please speak with your personal legal counsel to make the appropriate arrangements and draw up the legal documents. If desired, your attorney could personalize any of the following examples when structuring your will.

Beneficiary Designation A beneficiary designation gift is a simple way to make a gift to support the Bradley Impact Fund. You can designate us as a beneficiary of a retirement, investment or bank account, or your life insurance policy. To make your gift, collect a new beneficiary designation form for each account. Complete the form, including **Bradley Impact Fund, EIN 45-4678325** as the beneficiary, sign the form and mail it back to your broker, banker or agent.
